### Same Day Registration:

Same Day Registration is permitted at One Stop Early Voting Sites. Voters must provide proof of residence by presenting a valid document showing current name and address.

### Absentee By Mail:

Any registered voter who cannot go to the polls to vote on Election Day can request an absentee ballot mailed to them. Requests must be made on the State Absentee Ballot Request Form. Absentee ballot request forms must be in our office by 5:00 p.m. on Tuesday, November 1st.
